1. On any account, the Garbage shall not be burnt or kept more than 24 hours in the premises.
2. Usage of Plastic bags, Polythene bags, Disposable Plastic Cups are prohibited, if found any, during surprise checks, a fine of Rs.10000 for first time, Rs.50000 for second offence and Rs.10000 for Third time will be levied on the owner of premises.
3. NOC from the FSSAI should be obtained, for the Canteen / Mess.
4. Shall provide suitable means of drainage and shall maintain the same in good sanitary condition.
5. NOC from Fire & Rescue and Services to be obtained.
6. Any infection/Disease of staff or Students shall be notified atonce, to the City Health Officer.
7. Structural Stability Certificate, not later than 6 month, from Corporation Engineer, is to be submitted to the City Health Officer, Coimbatore Corporation.
8. To obtain Drinking Water Analysis Report (Samples from Sump & Over Head Tank) from Government Chief Water Analyst, Race Course, Coimbatore and to submit analysis report to the City Health Officer.
9. Shall provide access, without notice, for inspection by the city health officer or any person authorized by his in this behalf at any time by day night, when such premise is being used.

10. Display and Exhibition of Board: As per Rule 3 of the Tamilnadu Prohibition and Smoking and Spitting Rules 2008.

- ✓ Every person in charge of place of public work or use shall display and exhibit a board at a conspicuous place in or outside the place prominently stating that the place is as "No smoking and No spitting Place" and that Smoking or Spitting is an Offence which shall be both in Tamil and English and version in English shall be in the second place below the Tamil. Tamil Version shall be written predominantly in the board by providing more space than English.
- ✓ No sale of Tobacco, No Smoking or Chewing of Tobacco inside the premises of institution (By the Students, Staff and Teachers).
- ✓ IEC materials like Posters that give information about the ill effects of tobacco have to be displayed inside the institution
- ✓ Display of sign Boards on sale of tobacco produce around the institution within 100 yards banned.



11. Shall comply with the Tamil Nadu combined Development and Building Rules 2019.

12. Shall comply with all the provisions of the Solid Waste Management Rules, 2016.
